

FACILITY PERMISSION CONDITIONS

Air Emission

- In-plant roads in the facility will be cleaned regularly in order to prevent dusting in accordance with SKHKKY Annex-1.
- Existing principles and provisions of flue gas velocity and chimney height in chimneys where emissions are released to the atmosphere in the operation will be provided.
- Industrial Air Pollution Control published in the Official Gazette dated 03.07.2009 and numbered 27277 In accordance with Article 14 of the Regulation (SKHKKY), confirmation measurements are made every 2 years, and upon request, it is submitted to the competent authorities or will be presented to the inspectors during the inspections.
- Limit values in Annex-1 of SKHKKY will be provided.
- Operation of flue gas continuous measurement devices in the facility in accordance with SKHKKY Annex-3, legislation on testing, maintenance, installation and calibration of measuring devices to ensure reliability principles will be complied with.
- Additional regulations to be requested by the competent authority within the scope of Article 15 of SKHKKY will be complied with.
- The provisions and principles set forth in Article 6 of SKHKKY will be complied with in the enterprise.
- Within the scope of SKHKKY Annex-3.d.1 / Annex-5.A.1.9, continuous measurement results are evaluated and emission limit, If the values are exceeded, necessary measures will be taken.
- Included in Appendix-1 of SKHKKY to prevent dust caused by bulk materials stored in the open at the operation site measures will be taken. Transporting, storing, emptying the filters of the material that will cause dust in the operation area

Precautions listed in SKHKKY Annex-1 will be taken during operation.

- Limit values in Annex-5 of SKHKKY will be provided.
- The flue gas treatment units in the facility will be operated during production.
- Regarding the changes to be made at the facility, the provisions in Article 11 of the Environmental Permit and License Regulation (ÇİLY) will be obeyed.

Non-Hazardous Waste Recycling

- By operating within the framework of the information and documents submitted during the GFB/ Environmental Permit and License process,
- Informing the Ministry and other relevant institutions and organizations in case of an emergency,
- The wastes accepted to the facility by the waste treatment facilities, within one year from the date the waste is accepted to the facility.

by processing,

- To take all kinds of preventive measures defined in the relevant legislation against pollutants such as noise, dust, odor in the facilities,
- Carrying and storing fluorinated greenhouse gases that damage the ozone layer or have a greenhouse effect at the facility. If found, the gas in the containers used for this purpose is removed from the containers and disposed of appropriately To have the necessary equipment to ensure the storage
- They are obliged to comply with all other relevant legislation provisions.

- The continuity of the physical conditions that are the basis for the Provincial Directorate's Conformity letter regarding the permit and license issues by providing information to the Provincial Directorate in case of changes in physical conditions,
- To provide/provide the training of the personnel for the safe management of wastes or to provide vocational training in the relevant field Employing personnel with a Vocational Qualification Certificate approved by the Qualifications Authority,
- Hazardous waste waiting for more than 6 months in the Temporary Storage Area and Segregated Waste Storage Area of the enterprise.
- -not having non-hazardous waste waiting for more than one year,
- Characteristics defined by the (M) sign in Annex-4 of the Waste Management Regulation and specified in Annex-3/B of the Regulation It has been determined that the wastes that are claimed not to contain are non-hazardous with the analyzes made by laboratories authorized by the Ministry. by documenting,
- By complying with the provisions in Article 11 of the Environmental Permit and License Regulation regarding the changes to be made at the facility,
- Waste/waste that is not suitable for processing and/or outside the waste codes that it can accept to the facility within the scope of the document not accepting the codes to its facility,
- By registering to the online programs of the Ministry and making notifications and declarations, according to their field of activity; admission to the facility wastes processed, residual wastes and products/materials/segregated wastes generated as a result of waste processing activities
- -To approve the mass-balance notifications containing the information of the wastes simultaneously with the physical transactions,
- Buildings put into effect with the Council of Ministers Decision dated 27/11/2007 and numbered 2007/12937 in waste treatment facilities.

By complying with the obligations brought by the Regulation on Fire Protection,

- Waste treatment plant, necessary environmental impacts and control after closing plan approval from the Provincial Directorate and monitoring,
- to Transfer their wastes to waste treatment facilities that have GFB / environmental permits and licenses in accordance with the principles determined by the Ministry.
- The products/materials obtained as a result of the processing of wastes, separated wastes, residual wastes and/or
- -To comply with the provisions of the relevant legislation in the use or management of materials that cannot be evaluated,
- By checking the consistency of the wastes to be accepted to the facility, in case of inconsistency and inconsistency, they are accepted to the facility Notifying the Provincial Directorate of undelivered wastes within 24 hours,
- Not exceeding the annual waste consumption amount included in the instantaneous capacity report in the waste acceptance units
- -In cases where the report cannot be prepared, the capacity report is specified in other documents obtained from the competent authorities.

The annual waste consumption amount is taken as basis. Presenting a document from the competent authorities that it is exempt from the capacity report facilities are based on the amount specified in the institutional academic report showing the annual waste consumption amounts.)

- Not accepting waste water, gas, radioactive, explosive materials and materials with a risk of infectious disease in the facility,
- Information on the products/materials accepted, processed and exited from the facility and wastes in the facility in electronic form.
- -maintain a data recording system in which it is recorded and documents pertaining to the information entered into the data recording system for at least five years by keeping it for a long time,
- In the waste acceptance unit, the wastes accepted to the enterprise, the waste/products obtained as a result of its activities. Separated waste stock By collecting the other wastes separately in the temporary storage area,
- By complying with other issues to be determined by the Ministry and Provincial Directorate of Environment and Urbanization,

Packaging Waste Recycling

- Businesses log in with the user code and password previously given to them from the packaging information system.
- are required to enter.
- The "Waste Management Application" of our Ministry at https://ecbs.cevre.gov.tr Balance entries must be approved by the last day of the following second month at the latest.
- Regarding the amount of waste accepted, processed and disposed of at the facility and the amount of recovery and/or recycling

These records must be kept for five years.

- From receiving the waste to the facility, to its recovery, to the final disposal of unrecovered waste and waste originating from the facility Waste management up to the present should be done within the scope of environmental legislation and related regulations.
- In order to increase the knowledge level of the personnel working in the enterprise, a training plan will be created and the packaging wastes will be returned to the personnel.
- Training will be provided on conversion, record keeping, cleaning, regular operation and daily maintenance of the facility.
- Regarding the changes to be made at the facility, the provisions in Article 11 of the Environmental Permit and License Regulation (ÇİLY)will be obeyed.
- Annex-IV of the Waste Management Regulation, published in the Official Gazette dated 02.04.2015 and numbered 29314

No waste is accepted to the facility, except for the wastes in the list of wastes allowed within the scope of the Environmental Permit and License Certificate should not be done.

- The fire department report must be obtained from the municipality.
- In case of closure of the facility, necessary work and work within the framework of the provisions and principles of the Waste Management Regulation transactions need to be made.
- The operation complies with the provisions and principles of the Regulation on Control of Packaging Wastes dated 27 December 2017 and numbered 30283 must operate.
